Dear 5th Grade Parents/Legal Guardians,

As you know, the 5th grade graduation is approaching quickly. Once again, we are offering the opportunity to sell candy bars to assist with the 5th grade Graduation costs of \$150.00 (see prior letter). In order to cover all Graduation costs, you and your child will have the opportunity to sell 5 boxes of chocolate to meet the \$150.00 cost.

Selling chocolate bars is optional. If you do not want your child to sell any chocolate, you will be responsible for paying the full amount of \$150.00 by cash or money order by April 19, 2017.

For every box of chocolate that your child sells, half of the profit will go towards the child’s graduation costs and the other half goes to pay the chocolate company. For example, if you sell one box of chocolate (\$60.00 value), \$30.00 will go towards graduation fees and \$30.00 will go to the chocolate company.

Each box of chocolate is worth \$60.00.

Your child can choose to sell:

a box of 60 bars for \$1.00 each or a box of 30 bars for \$2.00 each

No boxes of chocolate will be given to students without a signed approval from parents.
